### **Minutes of the Parish Council meeting held on 11<sup>th</sup> April 2016 at 7.00pm at RAF Manston History Museum, Manston**

- Cllr Samme opened the meeting and welcomed everybody in attendance.

- 03/16-17** **Presentation re Stonehill Park**  
Presentation regarding background and plans for the development of StoneHill Park.
- 04/16-17** **MINUTES OF THE PREVIOUS MEETING**  
It was proposed by Cllr Samme seconded by Cllr Dearing and resolved to accept the Minutes of the Parish Council Meeting held on 14<sup>th</sup> March 2016. These were signed by the Chairman as a true record.
- 05//16-17** **FINANCIAL MATTERS**  
a) Members resolved to approve the Schedule of Payments which was proposed by Cllr Samme and seconded by Cllr Tritton , All in favour. Cheques signed as appropriate.
- 06/16-17** **CHAIRMANS REPORT**  
Beacon lighting is taking place on 21<sup>st</sup> April 2016 at 7.30pm. Cllr Tritton confirmed the food/electricity and possible shelter is sorted.

The airport is still as an airport in the current Local Plan. TDC last week voted to leave the EU. Weatherspoons in Ramsgate has obtained approval. Port Ramsgate - ships coming in with cargo and it is doing well. Portland – TDC are currently reviewing the decision.
